- I. With a Quorum in place, this meeting was called to Order By: Ed Suslovic at: 3:32 pm
- II. Public Forum: No members of the public present
- III. Approval of March 14, 2024 Meeting Minutes:

Ed Suslovic proposed for approval, John Thompson motioned, seconded by Paul Bradbury. After a roll call of the members present, the minutes were unanimously approved.

IV. Town of Gorham Metro Membership:

Greg lead the discussion with the Gorham Metro Membership. Gorham Council voted to join Metro, contingent by having two seats on the board. There was a discussion about board representation. It was decided to give Gorham the option of a 2-weight vote with one seat or a two-person 1 weight vote. With 1 member being preferred to make managing the board size easier but the committee said that two board members with 1 vote weight was also acceptable. Greg said he would check with the Gorham Town Manager about the town's preference. Ed Suslovic motions the suggestion to be brought to the board, moved by Hope, seconded by John, it's unanimously approved to bring to the board.

V. Process for Selecting a Permanent Executive Director:

Greg Jordan leads the discussion for a search for a permanent Executive Director. Two hiring firms have responded positively with proposals. Greg reviewed them and recommended additional Metro staff assess them before a final recommendation on which firm to select be

brought back to the committee in a special Executive Committee meeting March 28, 2024 at 3:30 pm.

VI. Executive Director Transition:

Greg and Glenn lead the discussion on the transition. Things are stable, though sadly one of our bus operators passed away today. They updated our PACTS funding and where we're at, including the presentation for April for the Finance Committee. Staff have reached out to Drummond and Woodsum to assist with union contract negotiations. Michael Shaughnessy needs a committee assignment.
