- Building Permit is already obtained and work is ready to begin ASAP.
- The SAT & Carpet tiles will be supplied by the Owner (Metro).
- There is no specific sprinkler contractor that Metro is contracted with.
- Access to the spaces will be from the corresponding exterior doors near each work area and should limit travel through the Metro Offices.
- Structural will need to take a look at the CMU lintels when contractor opens up. Notify architect 3 workdays before so they can coordinate with Structural.
- Both fire-rated doors will need to be tied into the fire-alarm system. This includes the Overhead Door.
- Sealed bids are due at 1:00PM on November 18th at Port City Architecture, 65 Newbury Street, Portland Maine.
- This is a Davis-Bacon wage determination.
- There are no bond requirements.
- An SK will be issued with the detail for the window well in the next addendum.
- Metro is open Monday through Friday from 5am to midnight. No work shall be performed between midnight to 5am. Notify Owner of work schedule.
